1. Objective

The examination is designed for a candidate who intend to be a competent person as a Site Safety Supervisor. The Objective of Site Safety Supervisor Competency Examination is to assess the candidate knowledge and understanding pertaining to their role and responsibilities as stipulated under Regulation 25 and 26 of Factories and Machinery (Building Operations and works of Engineering Construction) (Safety), Regulations 1986.

2. Minimum Entry Requirements

- a) Malaysian citizen; AND
- b) Minimum LCE/SRP/PMR/PTTT or equivalent; AND
- c) Fully attended Site Safety Supervisor course conducted by DOSH approved training center;

Candidates must pass papers 1 and 2 of the examination within two (2) years from the date of the first examination. Candidate who fails to meet the above examination requirement must be re-enroll in the Site Safety Course.

6. Criteria for awarding Site Safety Supervisor Certificate

A Site Safety Supervisor certificate will be awarded to the candidate who has complete and passes the Site Safety Supervisor programme.
