A. TUGASAN TEMPAT KERJA

1. Pilih satu tempat kerja.
2. Laksanakan pemantauan diri menggunakan pensampelan berturutan jangkamasa penuh atau separa (*full or partial period consecutive sampling*) untuk sekurang-kurangnya satu (1) jenis bahan kimia berbahaya kepada kesihatan (BKBKK) bagi sekurang-kurangnya dua (2) kumpulan pendedahan yang serupa (SEG) seperti berikut:
 - i) SEG 1 : Minimum 1 bahan kimia (BKBKK)
 - ii) SEG 2 : Minimum 1 bahan kimia (BKBKK)
3. Jalankan pemantauan berpandukan kepada *Guidelines on Monitoring of Airborne Chemical Hazardous to Health 2022*.
4. Sediakan laporan pemantauan mengikut format laporan yang dilampirkan.

B. FORMAT LAPORAN

 - ii. *The fonts used must be Times New Roman size 12 and using 1.5 spacing (except for title page).*
 - iii. *The left and right margin must be 2.5 cm, while the top and bottom margin must be 2.5 cm and formatted in paper sized A4.*
 - iv. *The report must have a front cover (Please refer to Appendix I).*

2.5 METHODOLOGY (15 marks)

- i. Method used.*
- ii. List of equipment used (serial number, calibration and expiry date).*
- iii. Type of sampling media used.*
- iv. Selection of worker from Similar Exposure Group (SEG).*
- v. Justification on monitoring duration and number of samples.*
