1. Objective

The examination is designed for those who intend to be an **ERGONOMIC TRAINED PERSON FOR ADVANCED ERGONOMICS RISK ASSESSMENT.** The objective of the examination is to assess the candidate knowledge and understanding pertaining to ergonomics risk assessment at the workplace based on Guidelines on Ergonomics Risk Assessment at Workplace 2017.

2. Entry Requirement

- 2.3. Candidates shall have attended and passed Ergonomic Trained Person for Initial Ergonomics Risk Assessment (ERA1) conducted by NIOSH or any other training provider approved by DOSH; **AND**
- 2.4. Candidates shall have attended Ergonomic Trained Person for Advanced Ergonomics Risk Assessment (ERA2) course conducted by NIOSH or any other training provider approved by DOSH.
